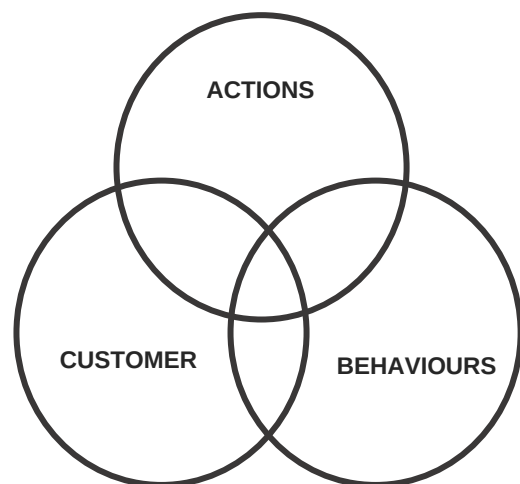

- 5** To be responsible for the safe preparation of the learning environment, equipment and session delivery as required by the programme.
- 6** To develop a 1:1 mentoring relationship with young people needing support where necessary aimed at achieving the goals defined in the action plan.
- 7** To be responsible for the safety and safeguarding of children and young people.
- 8** To maintain accurate records on named students which measure the impact of your intervention.
- 9** To be responsible for clothing, kit, equipment, data capturing devices and any resources at all times.
- 10** To undertake training where required and attend opportunities for development.
- 11** To be responsible for the health and safety of themselves and others in accordance with the Health and Safety at Work act 1974.
- 12** Any other duties commensurate with the grade of the post as directed by the Line Manager.

The person undertaking this role is expected to work within the policies, ethos and aims of Newport Live and to carry out such other duties as may reasonably be assigned by the Chief Executive of Newport Live.
